Each State/Provincial winner will also be eligible to compete for the Boy's and Girl's National AQHA/NHSRA or NHSRA WD Horse of the Year at the NHSFR or WJHFR.

CRITERIA FOR NOMINATION

- 1) Nominated horse(s) must be registered American Quarter Horse by the nomination deadline. All ownership information/transfers with AQHA must be current by the nomination deadline. **No pending work will be accepted. Everything must be complete by the nomination deadline.**
- 2) Nominations will only be accepted if completed and signed by the listed owner on AQHA papers. "Owner" is defined by one of the following: NHSRA or NHSRA WD member, parent(s), sibling(s) or grandparent(s).
- 3) Both the listed owner and rider must be a current AQHA or AQHYA member.
- 4) The earliest received nomination will break any ties.

NOMINATION DEADLINE MUST BE RECEIVED IN THE NHSRA OFFICE BY MARCH 1ST, 2010.

- **If the owner or rider's AQHA/AQHYA Membership expires between February 15, 2010 and August 1, 2010 please renew the Membership no later than February 15, 2010 to keep your Membership current.**
- **LATE NOMINATIONS WILL NOT BE ACCEPTED AND THERE ARE NO EXCEPTIONS TO THIS RULE! A nomination received in the National Office later than March 1st, 2010 is ineligible.**
- **ALL faxes will be date-stamped by NHSRA or NHSRA WD personnel. March 1, 2010 is the fax deadline.**
